### Preparing your child for preschool.



# What is different in the classroom?

We have hand sanitising units beside each door to the preschool/afterschool club.

Children will sanitise/wash their hands, on arrival into the preschool every day. Hand washing will be done regularly.

The staff will only be wearing masks

/ visor while parents are settling in children with the ECCE. Once the parents have left the teachers will remove their visors/masks

The layout of the classroom and the toys is the same. The children will be encouraged to play the same way; ensuring sneezing and coughing etiquette.

All equipment is separated and cleaned between the preschool and the afterschool classes.

### **Settling into Preschool**

Our preschool class will start back on Monday 31<sup>st</sup> August 2020. We are expecting our children to take some time to settle into their new routine having been at home for so long during Covid. We are very aware of children's emotions and their attachment to their families so we expect that some children will find the transition more difficult than others.

In light of this we will be settling the children in for:

40 minutes on Monday 31st August

50 minutes on Tuesday 1st Sept

2 hours on Wednesday 2<sup>nd</sup> Sept



We hope that this will make the transition as positive and easy as possible. On the first two days the children will be divided into 3 groups and will attend only with this small group. On the Friday we will bring the class all in at the same time. We will contact you with the time your child will be settling in.

On Monday parents can enter the pod with their child if needs be in full PPE which we will supply to you.

We will always call you if your child is not settling to afford you the opportunity to arrive earlier to collect your child. The settling in experience may be different for each child and we respect that. Constant communication is imperative for us to understand your child's needs. So please talk to us all the time. You are their voice.

### Drop and Collecting your child:

Each classroom is now called a Pod. Each pod has been colour coded. The colours of our Pods are: Blue and Red.

Next week we will upload a video of how to drop and collect your child. It will be on our website at, www.childsplaycreche.ie



You may only arrive at your allocated time. You need to queue up at the blue footprints outside the gate of the yard and someone will come and collect your child. Parents are not allowed into the school yard or into the Pods.

You need to social distance when dropping and collecting. It is important you do not wait around outside when you drop your child as other parents are trying to queue up to drop their child.

When you collect your child, it is the same procedure. You queue up on the footprints and we will bring your child out to you. No parents are allowed access to the pods (outside of the first day of settling in).

If you need to collect your child early or drop them later, you need to call us and let us know your arrival time and we will go out and meet you at the footprints.

### **Communication for Parents/Guardians:**

You can call us at any time on 087 404 2957 and speak to your child's key person. If you would like to talk about something in detail, we can organise a meeting. If we or yourselves have any important or sensitive information, please contact us by phone to pass this over as there is not any privacy at the drop and collection points. We will call you with a handover if we need to give you any sensitive information about your child. This will not be handed over at the door to you.





Our curriculum meetings and parent teacher meetings will be held by zoom if face to face is still not recommended. Links and times will be organised with you nearer to the time.

We believe that open, honest and transparent communication are the cornerstone of building a positive relationship, therefore, it is important that the face to face restrictions do not hinder that. There are lots of ways for us to communicate and we encourage parents to use these methods instead.

### **ECCE School bag: What you need:**

Your child will need at least one clean change of clothes in his/her bag every day.

We would like you to bring in Wellie Boots for your child that can remain in the class for outside use, to ensure that your child can avail of the messy play activities in the garden that are so important for their development.

You would also need to bring in a large oversized t-shirt for art. Every child will have their own t-shirt.

## What your child needs:

- ✓ Once full set of change of clothes
- **✓** Wellie Boots
- **✓** Large oversize t-shirt



### **ECCE Lunch Box:**

Due to Covid-19 some extra hygiene precautions are necessary for everyone's wellbeing. It is important that your child have breakfast at home prior to coming into preschool and will get lunch at home after preschool class.

Therefore, they only need something tiny for snack, to ensure that they can engage in this social experience, in preschool.



#### Your child needs:

- ✓ a clean lunch box with no items that need to be refrigerated in it:
- X no dairy,
- X no meat products,
- X no Yops, etc..



### An example is:

- ✓ some fruit cut up into bit size pieces and
- ✓ a cracker or bread sticks,
- ✓ rice cakes, etc...
- ✓ with a bottle of water is perfect.

No nuts are allowed on the premises, no sweets, chocolate, yoghurt bars, chocolate spreads or fizzy drinks are allowed for healthy eating reasons.

### **Afterschool Club:**

Our breakfast club will commence on Monday 31<sup>st</sup> August 2020 in the Blue Pod. One staff member will stay by the gate as parents/guardians may not enter the school yard. If no one is there when you arrive please

### **Social Hour: 1.10 – 2.10pm**

Social hour will take place in the Blue Pod. If you would like your child to join the social club from 1.10 - 2.10 please contact us on 087 404 2957.

### Afterschool Club: 1.10 – 6.00pm

We are really looking forward to seeing all our afterschool children again

Schools will be kept together to minimise risk.

Siblings will be kept together to minimise risk.

The children from KTETNS, Gaelscoil and St Brigids School will be in the Blue Pod with siblings from the Social Hour.

The children from  $2^{nd} - 6^{th}$  class and their siblings (who are not in Social Hour) will be in the Red Pod.

All equipment is separated and cleaned between the preschool and the afterschool classes.
